#### The President's Climate Action Plan




Released in June 2013

- Organized into 3 Pillars to:
  - #1 Cut carbon pollution
  - #2 Prepare for the impacts
  - #3 Lead international efforts

 Charged the EPA with regulating emissions from new and existing power plants
